All you've got to do is *Just Tick It*

Gift Aid is a way to make your donations go even further without costing you a single penny!

*giftaid it*

If you are a UK taxpayer, Gift Aid increases the value of your donations by 25%. So for every £1 you donate, the government gives us an extra 25p. All you need to do is just tick the relevant boxes below and:

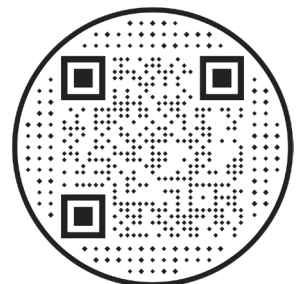
